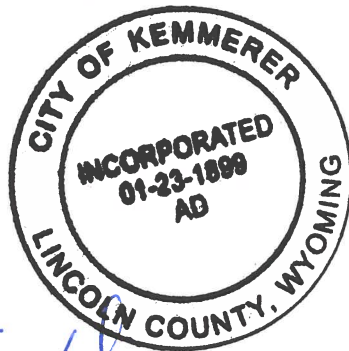
NEW BUSINESS:


COMMENTS:


